GROUP OR LEAGUE POLICIES AND PROCEDURES

- 1 Group size and tee times to be determined by the Head Golf Professional (minimum of 16 players per event) & (minimum of 15 events per year)
- 2 The Golf Course has the right at least 4 weeks out to terminate the date of a scheduled and contracted outing in the event that day is sold for a larger event to be held
- 3 A Roster of Members should be provided to the Golf Professional at the beginning of the Season
- 4 All Members of the League May purchase the Advantage Card (\$35.00) which is good for one (1) calendar year
- 5 ALL food and beverages must be purchased on site! NO COOLERS allowed on the course.
- 6 The Reservation Fee of \$5 per time is Paid at the Signing of the Contract.
- 7 The Handicap Program will be Offered to ALL League Members at 20% off the Regular Rate (USGA Certified)
- 8 If the group fails to have 90% compliance with the reserved number of rounds on a date, the shortage fees may be billed to the League.
If the League falls below the 90% Compliance more than Twice, the Course has the Right to Void the Contract (Unused Reservation Fees Will Be Refunded for the Remaining Contracted Dates)
- 9 Weather Policy: Once the group begins play, there are No refunds unless the course is closed and deemed unplayable by the Golf Professional on duty. The group will be obligated to play and be held to the 90% compliance if the course is open and the majority of the public booked tee times are being utilized. If the weather looks bad, the chairperson should call the course 2 hours prior to the first tee time to discuss the options. If the weather is suspect, it is recommended that the group show up at the course to make their decision. The Weather Policy is posted at the Course for more details.
